Lionel Youst Collection at the Coos History Museum Research Library

In 2014, at the urging of museum collections manager Vicki Weise, I spent about six months organizing and inventorying my research materials relative to local Native American history. I had accumulated these materials while writing biographies of two significant local Native American consultants to several anthropologists dating from 1903 to 1934. These researches resulted in publication of two biographies published by University of Oklahoma Press in its "Civilization of the American Indian" series, volumes 224 and 253: *She's Tricky Like Coyote: Annie Miner Peterson, an Oregon Coast Indian Woman* (1997), and *Coquelle Thompson, Athabaskan Witness* (2002).

I organized these materials for donation to the museum into two boxes, "Box 1, Research materials associated with writing of *She's Tricky Like Coyote*," and "Box 2, Research materials associated with the writing of *Coquelle Thompson*." I submitted them as "Lionel Youst Collection, Box 1 and Box 2" to the old museum in North Bend during the summer of 2014, to an enthusiastic reception. I went through each of the items with Vicki Weise and others, including Don Ivy, who was soon to be elected Chief of the Coquille Indian Tribe.

The museum was readying itself for its ultimate move to the new museum in Coos Bay. Public information pertaining to the new museum included an emphasis on a proposed "research library." I had assumed that my collection would be made available at this proposed library for unrestricted research, and for that reason I went to considerable pains to make the inventory of it complete and clear. It contains both published and unpublished matter pertaining to the several anthropologists who had been active locally; matter pertaining to history of the two local Indian tribes – including the reservation period at the Yachats Subagency and at the Siletz Reservation; matter that could be of interest to persons doing genealogical research; in addition to the biographical information of the subjects of the two books. It wasn't until 2018 that the museum's accession of the collection was completed by the then curator, Debra Semrau.

At the time of the accession, all of the items on my inventory were there, except the set of 9 (nine) microfilm reels of the field notes of John Peabody Harrington. These microfilm reels had been donated by Jim Thornton, Coos County Indian Education Coordinator. In 2017 I saw them, still in Box 1, while I was looking for something in the collection. They were missing when the box was accessed the following year. Someone had removed those microfilm reels and they remain missing. Fortunately, the Smithsonian Institution has since made them available on-line for anyone patient enough to learn how to access the site.

The collection contains more than 20 published books, some of them quite rare, and a large number of documents in folders or bound in report covers, data binders, and notebooks. The following pages are my original inventory of the Lionel Youst Collection, Box 1 and Box 2.

Note:

Following is the inventory which I provided to the Coos History Museum at the time I donated the collection in 2014. When the collection was at last accessed by the museum in 2018, the accession number assigned was A (or L) 017.5, plus a number indicating the specific item 1 through 78. The items were assigned their specific accession numbers in the same order in which they appear on my inventory, with a few minor exceptions. Items from my Box 1 have accession numbers 1 through 38. Items from my Box 2 have accession numbers 39 through 78. I have gone through and indicated to the left of each inventory item the corresponding accession number. That should make it easy to identify the item with the museum staff when requesting access to it.

The collection covers material from several related subjects. Much of it is rare and hard to access from other sources. Some of it is unique.

A. Anthropologists, their lives and their works:

1. John Peabody Harrington. Scattered through the collection is an almost comprehensive accumulation of materials relative to this important Smithsonian anthropologist.
2. Jack Marr, associate of J. P. Harrington – includes his correspondence and writings.
3. Melville Jacobs. Most of his published writings are included.
4. Elizabeth Jacobs, wife of Melville. Her two year's of interviews with Coquille Thompson, and other materials.
5. Philip Drucker. Coos notes.
6. Homer G. Barnett. From his notes.
6. Leo J. Frachtenberg. Includes his Coos, his Lower Unpqua, and his Alsea texts.
7. Harry Hull St. Clair 2nd, his collection of Coos myths during summer 1903.
7. Cora DeBois. Her fascinating study of the 1870 Ghost Dance, including the Coquille Thompson version.
8. William R. Seaburg. His work with Elizabeth Jacobs and researches into the contributions of Coquille Thompson and other published and unpublished works.

B. Genealogical materials:

1. Allotment records from the National Archives, Region 10, Seattle. 375 loose pages of interviews to determine heirs of Siletz Indian Allotments. A treasure trove of genealogical information.
2. Several notebooks and report folders of items collected during Lionel Youst's researches, including interviews, letters, pictures, marriage and death certificates, census, and other documents.

C. Local History (examples):

1. Typescript of Pocket Diary of Joel Palmer, and other material from Palmer.
2. Material from the Office of Indian Affairs, 1854-1906, and other materials.
3. A cursory look at the following inventory will reveal a large number of documents which are relevant to various specific matters in interest to the local historian.
